General Requirements of Eligibility

1. The Applicant must be enrolled in a post-secondary education program.

2. The Applicant must show proof of enrolment as a full-time student in the above-mentioned program.

3. The Applicant must complete the application form.

4. The Applicant must provide a recent colour photo, with their application, to SE Mutual for possible publication.

5. The Applicants must not have received any scholarship and/or bursary monies from SE Mutual Insurance prior to this submission (applicants may receive only one scholarship and/or bursary from SE Mutual).
